## Mar Qardakh School Mission Statement

Our mission is to empower students for life in the 21<sup>st</sup> century by providing them with a holistic, international education encompassing academic, social, spiritual and personal development.

# I. Philosophy

Information technology plays a pivotal role in the education of the rising generation. Technology pervades all aspects of our lives offering new possibilities to the experience and quality of human services across all domains of human endeavour. With an expanding range of technology endowed services.

At Mar Qardakh, we believe that technology literacy is critical for students to succeed in their education and in their future careers. In our rapidly changing world, it is not enough merely to be competent in a variety of core computer skills. Rather, successful graduates must be able to assess a problem and determine how best to use the technological tools at their disposal to resolve problems, identify solutions and propose advancements to daily challenges not just in the workplace but also in their lives. They must be flexible and creative in meeting real-life challenges with informed and innovative solutions.

With the growth of the Internet, an unprecedented amount of valuable information is available to those who know how to locate and evaluate it. We believe that in order to conduct online research in a productive, scholarly and honest manner, students must be able to distinguish useful information from irrelevant or 'fake' information; identify a reasonable number of resources from an enormous pool; and discern which sources are legitimate and which are illegitimate.

# II. Technology at Mar Qardakh

#### 1. Laptops

Every Mar Qardakh student owns a laptop designated for use in school. Each student is held responsible to bring his or her laptop to school every day and to keep it charged as needed.

Mar Qardakh students' laptops are among their most valuable learning tools. The laptop provides ongoing hands-on practice in crucial computer literacy skills, and encourages students to take responsibility for their learning by placing tools and information directly into their hands. The laptop is a central location for students to organise their thoughts and work, and complements the transdisciplinary and multidisciplinary emphases of the curriculum.

#### **2. ManageBac** (marqardakh.managebac.com)

ManageBac helps schools implement and manage their IB systems efficiently. This online management system gathers information on IB student profiles, unit planning, and assessment data information. Every Mar Qardakh teacher, student and parent has a unique ManageBac account.

#### 3. Mar Qardakh School Management System (MQSMS)

The MQSMS platform is accessible from every Starboard. This is a secure electronic school-wide management system which facilitates the administrative requirements of taking attendance, reporting grades to the Ministry, and communicating daily announcements among administrators and teachers.

# III. Acceptable Use Policy

This policy applies to student laptops as well as all Starboards, computers, and related devices belonging to the school.

 Student laptops must comply with the school's published specifications (appendix II and III).

**Note:** This guarantees that students will have the minimum required software to successfully access, complete, and otherwise participate in all assignments and tasks. Failure to adhere to these standards may put students at risk of falling behind in their schoolwork.

- 2. Students and teachers are responsible to care for all equipment that they use, to use all equipment appropriately and safely, and to immediately report any damage or malfunction to the IT Department.
- 3. The school recommends that teachers and students purchase a USB drive to facilitate work with electronic files.
- 4. Passwords, usernames, and other login information are private and confidential, and should not be shared with anyone.
- 5. Acceptable use of the Internet is outlined below:
  - a) The Internet is to be used only for educational purposes. Students are not to access personal email, social websites, or games, while at school.
  - b) In all online interactions, teachers and students shall be polite, respectful, appropriate, and shall positively represent the school.
  - c) Possession of objectionable content (including, but not limited to, pornographic, violent, and drug-related material), online harassment or bullying, and other misuse of internet privileges will not be tolerated and will incur an appropriate level of sanction according to the level of breach.
  - d) The school reserves the right to determine what constitutes acceptable use of the internet.

## **Violations of Acceptable Use Policy**

We follow a three-warning system for violations of the above policy, as outlined below:

First offense	First warning. Parents will be sent a notice. The incident will be recorded with the appropriate Coordinator and the Head of School and placed in the student's file. The school will undertake individual counselling with the student.	
Second offense	Second warning. The student's laptop will be confiscated and returned only to the parents. The incident will be recorded with the appropriate Coordinator and the Head of School and placed in the student's file. Parents must schedule a conference with the school to discuss the offense and collect the laptop.	
Third offense	Third warning. The student's laptop will be confiscated and returned only to the parents. The incident will be recorded	

	with the appropriate Coordinator and the Head of School and placed in the student's file. Parents must schedule a conference with the school to discuss the offense and collect the laptop. Parents must sign a form acknowledging their understanding that any additional violations will result in the student losing the privilege of using a laptop in the school.	
Fourth offense	<b>Disciplinary action.</b> The student will not be permitted to bring his or her laptop on school premises or use a laptop in the school. As we are a laptop-based school, this will compromise the student's ability to succeed in school.
